In terms of SBIPA (Ahmedabad) Circular dated 18.06.2026, I, Parag Buch, the undersigned have been appointed as Chairman of the Election Committee to conduct the Triennial Election for SBIPA, (Ahmedabad) for its term 2026-2029.

2. With a view to assist in smooth handling of election process following members have been appointed as the Members of the Election Committee:

- I. Shri Piyush Shah
- II. Shri Chandrakant Jajal
- III. Shri Devang Chhaya
- IV. Shri S.M. Bukhari

3. The notice is hereby given that eligible members who wish to contest Election in terms of By-Laws of State Bank of India Pensioners' Association, (Ahmedabad) and willing to contest shall file their nominations for the post /posts indicated in enclosed chart as Annexure 'A'. The chart also gives information about total number of posts, name of the posts, details of the post number, eligibility criteria for members to file nomination for respective posts and also eligible voters for the respective posts. The members, who desire to contest the election, shall submit their nomination in the prescribed format (specimen enclosed as per Annexure 'B') between 06.07.2026 (Monday) and on or before 10.07.2026 (Friday) latest by 4.00 p.m.

4. The date wise programme for conduct of election process is as under:

Filing of Nomination to commence from	06.07.2026, Monday
Last Date for filling Nominations	10.07.2026, Friday up to 4.00 p.m.
Publication of list of valid Nominations	13.07.2026, Monday after 4.00 p.m.
Last Date for withdrawal of Nominations	From 14.07.2026, Tuesday to 15.07.2026, Wednesday up to 4.00 p.m.
Publication of final list of Nominations	16.07.2026, Thursday after 4.00 p.m.



Date of Election	25.07.2026, Saturday between 11.00 a.m. to 4.00 p.m.
Counting of votes	26.07.2026, Sunday from 10.00 a.m. onwards

Results will be declared after counting is over. The decision of election committee will be final and binding on all members.

Those contestants who wish to withdraw their nomination(s), may do so by filling up the Nomination withdrawal form (Annexure 'C'), between 14.07.2026 and 15.07.2026. The withdrawal form should reach us latest by 4.00 p.m. (15.07.2026).

Important:

1. The eligible member is allowed to file nominations for maximum three different posts only. In case where nominations are received for more than THREE posts by same member, decision whether to allow that member to contest or reject any nominations shall rest with the Election Committee.
2. Nominations for various positions should be duly proposed and seconded by different members of SBIPA - (Ahmedabad) and signed by the candidate in full in token of his/her consent.
3. If a member has proposed one candidate for a post, he/she cannot propose another candidate for the same post. However, he/she can propose candidate for another post. A member can propose maximum three candidates only.
4. Similarly, if a member has seconded one candidate for a post, he/she cannot second another candidate for the same post. However, he/she can second candidate for another post. A member can second maximum three candidates only.
5. Contesting candidates are requested to furnish their names in the nomination form correctly as per HRMS. The name stated in nomination form will be printed in the ballot paper, in same order, without any change.
6. In case, a member gets elected for more than one post, member will retain one post only and has to resign from the other post(s) within 24 hours of declaration of result. The resultant vacancy shall be filled in by declaring next candidate having scored maximum votes in same category. If the member does not resign, the decision of the Election Committee will be final.
7. The election will be done through Secret Ballot Paper of single non-transferable vote and every member shall be allowed to exercise his/her vote on pre-decided date, venue and time. The member whose name appears in voters' list of a particular District will only be allowed



to VOTE ON THE SPOT at venue. Exact venue for voting will be advised by a separate circular.

8. Only those members engaged in election duty and going to other venue for conducting the election duties will be delivered Ballot papers in advance. After exercising right of voting, they need to hand over the ballot paper to the Chairman, Election Committee in a sealed cover.

9. Criteria to Contest, Propose, Second and Vote for various posts:

i. For the posts of President, Vice President, General Secretary, Joint General Secretary, Organising Secretary, Treasurer and Assistant Treasurer, Deputy General Secretary (Admin Office), any primary member of SBIPA, (Ahmedabad) can contest, propose, second and vote.

ii. For Executive Committee Member of any district (i.e. from Serial Number 9 onwards), primary members residing in respective district can contest, propose, second and vote.

5. Attention "Candidates":

i. He/she must be a primary member of SBIPA- (Ahmedabad) as on 31.03.2026.

ii. Nomination forms duly completed may be handed over / dispatched to the Chairman, Election Committee in a sealed cover duly super-scribed "Nominations for the Post of: _____ Post No: _____ (Separate envelope for different post), so as to reach latest by 4.00 p.m. on 10.07.2026 (Friday), at below mentioned address:

iii. Nominee / Candidate intending to contest election must submit his /her Pension slip of 31.03.2026.

6. Attention Members:

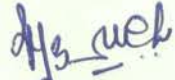

ii. Members should bring followings for verification of the member in the voter list:

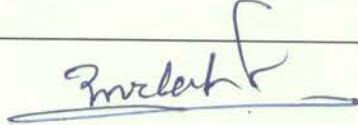
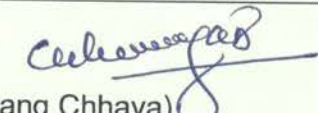
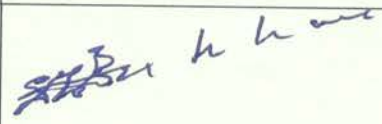
- a. Identity card issued by the Bank to Pensioners / Family pensioner or
